#### Background

Many Central European nongovernmental development organisations (NGDOs) implement projects with the support of government or EU funds. The Central European ODA mechanisms are at a developing stage, the flow of grants is often not well-enough structured and it is quite difficult to obtain grants or benefit from them on a regular basis. One of the challenges is a demand for co-financing. Successful grantees must provide significant amounts of own contribution and/or matching funds from alternative – individual or corporate – sources. In addition, the organisational development of NGDOs needs unrestricted sources of financing, to stabilise and consolidate their programs and expertise.

There are several examples of successful NGDOs in the region that are able to fundraise from private sources regularly. But equally, many Central European NGDOs have not yet set up fundraising mechanisms from independent sources, nor have the knowledge and experience to do so. They feel the need to develop mechanisms to diversify income, strengthen their fundraising capacity as well as to develop and strengthen relationship with their constituencies and the general public, which are often unaware of humanitarian and development issues, or simply do not consider them important.

Conference is part of the *Strengthening Fundraising Capacities of NGDOs in Central Europe* project, which is supported by European Commission and co-financed by SlovakAid.
