





EU-12 development policies at half-time Europeanization, specialization, or both?

International conference organized by Palacký University in Olomouc, Czech Republic in cooperation with EADI Working Group on Development Aid of the Non-DAC Donors

Wednesday 15th – Friday 17th February 2012 Palacký University, Olomouc, Czech Republic Programme chairs: Petra Krylová (Palacký University) and Ondřej Horký (Institute of International Relations, Praque)

With the accession of the 'new' member states to the EU in 2004 and 2007 and, for some of them, to the OECD in the preceding years, the mostly post-communist countries have begun or renewed their bilateral and multilateral cooperation programmes as well as defined their national position towards the EU development policy. At this 'half-time' when the bases of their development cooperation programmes are laid down, the aim of the conference is to offer a time of reflexion on the outcomes of the interaction between the 'new' member states and the Union in a larger political and societal context. On the one hand, there is the unifying process of Europeanization that encompasses broader international commitments, and, on the other hand, the diverging specialization of the national development policies, especially in the efforts to transmit the transition and Europeanization experience of the 'new' member states beyond their borders. Unlike previous research, the conference will pay equal attention to the influence of the newcomers on the Union rather than vice versa only. Moreover, rather than a merely technical policy to be implemented by the member states, the development cooperation policies of the 'new' members states and the EU development policy will be considered as a component of their politics à part entière. Therefore, special attention will be paid to their embedment in the national and European public opinion, civil society, NGO sector, administration, political life, economy and employment. This aspect includes the use and misuse of development cooperation for other purposes than its stated objectives. Finally, the conference will encourage a critical assessment of the past ten to fifteen years of international development policies of the 'new' member states as well as the older heritage and current evolution EU development policy. The Commitment to Development Index which was developed by the USbased Centre for Global Development offers an interesting opportunity for assessing not only the development policies but more importantly the overall approach of the EU 12 towards the developing countries. However, considering the specificities of aid provided by the new member states many issues need to be discussed. The conference will aim to foster such debate and engage both scholars from the 'new' and 'old' member states and beyond.

Accordingly, conference papers (4,000–6,000 words) devoted to individual member states, will be presented at the conference. They will share a **common** methodological framework and structure:

- 1. Introduction: a historical outlook of the post-war and pre-accession period
- 2. The Europeanization of national development policy: rhetoric and implementation
- 3. The specialization of national development policy: possible transfer of transition experience, success stories
- 4. The embedment of development policy in a larger context (politics, society, economy)
- 5. A critical assessment of the national as well as EU development policy
- 6. Conclusion: the vision ten years ahead

Additionally to country focused papers, specific papers oriented at EU12 development agenda will also be presented as full conference papers.

There is no conference fee.

Discussion papers of 600 to 1000 words reacting on the conference papers will be accepted. The discussants may also choose one of the mentioned aspects the 'new' member states and comment on them in a comparative perspective. Finally, discussants from outside the EU-12 may present a discussion paper that evaluates the development policies of the 'new' member states form an outsider's perspective. University students and young scholars are especially encouraged to apply.

Selected conference and discussion papers will serve as a base for a **peer-reviewed monograph**, which will be published in 2012.
